Wednesday, January 4, 2017

The regular meeting of the Northern Nevada Water Planning Commission ("NNWPC") was held in the Washoe County Commission Chambers, 1001 East Ninth Street, Reno, Nevada and conducted the following business:

1. Roll Call and Determination of Presence of a Quorum

7. Review, discussion and possible direction to staff regarding the draft Regional Water Balance for possible inclusion in the "Population Forecast and Projections of Water Demand, Peak Day Requirements and Wastewater Flow" chapter of the 2016 RWMP update – Jim Smitherman. (For Possible Action)

Mr. Smitherman presented an overview of the staff report and provided an update on the status of the Regional Water Balance model. Once confirmation is received from service providers on some of the details on that model, a draft final product will be prepared for review at the next NNWPC meeting.

Mr. Smitherman presented an overview of the staff report for this chapter.

Commissioner Drinkwater discussed the CIP funding table and noted that it is not capturing all of the CIPs. Mr. Smitherman will follow up on that with Hansford Economic Consulting.

Commissioner Drinkwater noted that some of the language regarding the sewer connection fee implies that it discourages infill. If that is not the intent, some language about being revenue neutral would be appropriate.

9. Discussion and possible direction to staff regarding any chapters of the RWMP previously reviewed by the NNWPC in relation to the 2016 RWMP update – Jim Smitherman. (For Possible Action)

Mr. Smitherman presented an overview of the staff report reviewing a possible schedule for Plan adoption. The schedule would allow for the NNWPC to make a recommendation for adoption to the WRWC at a public hearing on March 1, 2107. This schedule would require that all comments for changes are received by February 8, 2017. At the earliest this schedule has a final adoption date of April 19, 2017.
